1. General comments

This final report was prepared within the EU Twinning Project" Support to the reform of the statistics system in Bosnia and Herzegovina".

Due to the outbreak of COVID-19 the last scheduled mission to take place 9 - 12 March 2020 was cancelled. For the same reason this report will be limited in scope and will only include few comments to the following chapters.

The MS experts would like to express their thanks to all officials and individuals met during the missions carried out under this project for the kind support and valuable information which we have received during our different missions in Bosnia-Herzegovina and which highly facilitated the work of the consultants.

This views and observations stated in this report are those of the consultants and do not necessarily correspond to the views of EU, BHAS, FIS, RSIS, CBBH, Statistics Denmark, INSEE, Statistics Finland and Croatian Bureau of Statistics.

2. Status at the beginning of the project

The project lasted two years. It aimed at testing the feasibility of disseminating Service Producer Price Indices (SPPI) by the three statistical institutes of Bosnia and Herzegovina and to implement such indices at the national level.

These indices are one of the indicators for improving the estimation of the volume development of activity in volume, hence to improve the calculation of the economic growth.

At the beginning of the project, BC experts had developed the following experimental SPPIs within seven NACE activities during the previous Twinning Project:

- 49.41 Freight transport by road
- 51.10 Passenger air transport
- 52.10 Warehousing and storage
- 52.24 Cargo handling
- 53.10 Postal activities under universal service obligation
- 53.20 Courier services
- 61 Telecommunication.

In addition, following activities have been introduced in the regular data collection in BiH: 80 Security and investigation activities and 81.2 Cleaning activities.

BC experts had started with previous mentioned activities because of the simplicity and availability of turnover data which made it possible to calculate also volumes.

The development of the abovementioned industries did continue, and this project did also provide support for the production of these industries.

3. Status of project results

The goals for the 2.4 sub-component were to

• Define new indicators for SPPI, produced by 8th project quarter (March 2020);

- Eventually implement the dissemination of these indices on a quarterly basis and a regular publishing calendar;
- Publish a methodological note presenting the principles of the SPPI calculation, the metadata and a quality report.

As written under the general comments, the last mission was cancelled due to the outbreak of COVID-19.

At the time of writing this final report, all the work covering the results are about to be finalised.

5. Recommendations for the future (short and long term)

BC experts have expressed their intention to continue to develop the scope of SPPI in the near future. MS experts are pleased to hear this and encourage to keep up the good work and good co-operation between the BiH experts. A long-term development plan for SPPI would be useful to have.

The data collection and validation is quite demanding due to the complexity of measuring the prices of services and the need for personal contacts to the reporting units. If possible, it would be useful to introduce web-based questionnaire. This could have the benefit of making it easier to obtain the relevant data (current price, previous price, reasons for price change or quality change etc.) from the reporting units and make the validation easier and more efficient.

MS experts suggest the teams responsible for SPPI in BiH to look for synergies with their colleagues responsible of other producer price indices as soon as the production processes and working practices will be fully operational.

MS experts recommend that BC experts continue their participation in international co-operation and meetings, e.g. the Voorburg Group on Service Statistics.

6. Identification of needs for additional support

It is highly recommended that relevant resources, meaning staff, should be allocated to the SPPI as the data collection and validation is quite demanding due to the complexity of measuring the prices of services and the need for personal contacts to the reporting units.
