Standard industrial groupings for publishing purposes

Industries organized into four groupings

For the purpose of facilitating the users' possibilities of comparing industrial information obtained from the various published statistics, Statistics Denmark has organized the total number of registered industries (825) into four standard groupings.

Groupings used in published statistics

The four standard groupings comprise 9, 27, 53 and 111 groups, respectively. These groups form the basis of using DB03 in statistics published by Statistics Denmark.

Links to DB03

The four standard groupings reflect an increasing aggregation of detail in the classifications. The 9-digit grouping is indicated by a one-digit code and a general text, whereas the 27-grouping is indicated by a four-digit code and a general text, the 53-grouping is indicated by a five-digit code and a general text and the 111-grouping is indicated by a six-digit code and a general text. The code structure is linked to the codes in DB03. The key between the 111-grouping and the associated 6-digit industrial codes is shown in annex 4.

Final digit denotes information

If the final digit of the codes is 0 the initial digits of the codes are thus identical with the initial digits in the detailed DB03 industries which are included in the standard group. However, this is not the case if the final digit of the codes is 9. The initial figures are then typically digits from the lowest DB03 industry which is included in the standard group.
